INFRASTRUCTURE PROJECT PRIORITIZATION CRITERIA (TRIPPC)

UNDER THE DOT-DPWH CONVERGENCE PROGRAM

The DOT-DPWH and DTI-DPWH Convergence Program National Meeting and Workshop held last September 19, 2017, the DOT- DPWH Convergence Program National Conference held last February 12, 2018, along with a series of Central Technical Working Group (CTWG) Meetings, resulted in inclusively collecting comments and suggestions in preparation for the Revised Guidelines for the Tourism Road Infrastructure Project Prioritization Criteria (TRIPPC) including the use of **Automated TRIPPC Forms in the submission of proposals.**

Through the TRIP TWG, we hereby direct the DOT and DPWH ROs to identify potential tourism roads and accomplish the Automated TRIPPC Forms. Only tourism road project proposals which have completed and signed Automated Forms shall be considered in the TRIPPC evaluation for the 2019 budget year. Please use the attached **Guidelines on the Automated Forms for the Tourism Road Infrastructure Project Prioritization Criteria (TRIPPC).**

The Transmittal Letter signed and certified by the respective DOT and DPWH Regional Directors is required for submission. The Transmittal Letter serves as a proof of endorsement of the proposed road project by both the Regional DOT and DPWH offices.

The <u>deadline</u> for the submission of the completed and signed TRIPPC forms and supporting requirements by the Regional TWG to the Central Technical Working Group (Central Offices of DOT and DPWH) <u>is March 15.2018.</u>

IMPROVED GUIDELINES ON THE TOURISM ROAD INFRASTRUCTURE PROJECT PRIORITIZATION CRITERIA (TRIPPC)

The TRIPPC Forms has three main sections: I) BASIC PROJECT INFORMATION, II) PROJECT EVALUATION GUIDELINES, and III) DETAILED ROAD INFORMATION.

- I. In the "BASIC PROJECT INFORMATION" section, the following details are required:
 - A. project name
 - B. funding year
 - C. region, province, municipality/city barangay
 - D. road classification
 - E. project description
 - F. proposed scope of work
 - G. proposed budget
 - H. total road length in kilometers (km)
 - I. total road project length for funding (km)
 - J. legislative district
 - K. district engineering office.

Also included in this section are **Tourism Information** which include the following details:

- A. grouping (whether Northern Philippines, Central Philippines, or Southern Philippines)
- B. cluster destinations
- C. tourism development area
- D. tourism sites and tourism destination types
- E. gateways and type of gateway
- F. service centers
- II. In the "PROJECT EVALUATION GUIDELINES" section, the following are required: A) Pre-qualification Criteria, B) Tourism Information Details, and C) Project Readiness.

II.A. Pre-qualification Criteria

The road project shall be evaluated by the Regional Technical Working Group (RTWG) using a simple checklist – on ten Basic Technical and Developmental Criteria (as shown in Table 1). The road project must pass <u>ALL</u> the criteria to complete the Pre-Qualification Stage. It is advised that the RTWG should not submit the project for approval until all the requirements have been fulfilled because it may be denied or subject to further evaluation.

TABLE 1: PRE-QUALIFICATION CRITERIA

BASIC TECHNICAL & DEVELOPMENTAL CRITERIA SUBJECT FOR EVALUATION

- 1. <u>Tourism Importance</u> Certification from DOT RD that the project is part of the regional tourism priorities and is consistent with the NTDP and meets the minimum acceptable score of importance.
- 2. <u>Technical Necessity</u> Certification from DPWH RD that the road is unpaved or paved road in bad/poor condition and thus, in need of improvement. For road opening, the DPWH RD must certify the necessity of a road opening in support of the Certification of the DOT RD in no. 1
- 3. <u>Location of the Project</u> Must be within 90 kilometers or less from a Tourism Gateway or a Tourism Service Center
- 4. <u>Project Development Map</u> Must show Points A and B as defined in Section II. B. below, the relevant tourism development areas and the relationship, connection, and importance of the road projects.
- 5. Right of way Availability –either of the following:
 - A. If project road is included in such LGU road inventory and its available Right of Way conforms to DPWH standards for tourism roads: a certification by the LGU head, as confirmed by the DPWH RD, that the project road is included in such LGU inventory with available ROW which complies with DPWH standards for tourism roads;
 - B. If the project road is included in the LGU inventory, but its ROW requires widening to conform with the DPWH standards: a certification from the LGU Head, as confirmed by the DPWH RD, that the required additional Right of Way will be made available before the inclusion of the project in the National Expenditure Program (NEP).
 - C. If project road is not included in such LGU inventory or if road opening: a certification by the LGU head, as confirmed by the DPWH RD, must have a Deed of Donation for the required Right-of-Way before the the inclusion of the project in the National Expenditure Program (NEP). A Conditional Deed of Donation using the attached template is also acceptable.
- 6. <u>Concept Study and Project Profile</u> Must be provided as minimum requirement
- 7. <u>Regional Development Council (RDC) endorsement</u> Must be provided as minimum requirement.

- 8. <u>Local Development Council (LDC) or LGU Head Endorsement-</u> Must be provided as minimum requirement.
- 9. <u>Stakeholder Endorsement</u> Must be provided from at least one private tourism-related organization or business association.
- 10. <u>Geotagged Photos of the proposed road projects and tourism destination and GIS Map-</u> Must show Points A and B as defined in Section II. B. and III.B. below.

II.B. Tourism Information Details

The **Purpose of the Road** (**Point A to Point B**) must first be identified as to whether the road connects a (1) tourism site to tourism site, (2) tourism site to service center or vice versa, (3) tourism site to gateway or vice versa, (4) service center to gateway (provincial bus terminal) or vice versa, (5) service center to gateway (seaport) or vice versa, (6) service center to gateway (airport) or vice versa.

A gateway represents either: an airport/ rail station/ seaport/ or inter-provincial/ national road. For inter-provincial/ national roads, the gateway shall refer to the inter-provincial boundaries.

A tourism service center refers to the staging area/s for tourist to the destination or attractions that offers a variety of amenities or facilities. These include accommodation, airports/ seaports/ inter-urban bus transport, local public and tourist transport, restaurants, entertainment facilities, banks/ money changers, hospitals, pharmacies, information centers, shopping, personal services and supermarkets. A tourism service center is strategically located and well integrated with an existing urbanized area, such a city or poblacion.

After determining the Purpose of the Road, the following Tourism Information Details, for BOTH Point A and Point B, are required:

- a. No. of Tourist Accommodation Rooms (Indicate in the certification of data the number of rooms)
- b. No. of Annual Day Visitors and Annual Overnight Visitors
- c. No. of Primary Enterprises Excluding Accommodation Establishments.

For all of the above, the year that the submitted data was collected must be noted down.

The following information details will then be scored based on the following guidelines:

The project must obtain a minimum total score of 60 points for either point A or B to be considered eligible for the Program.

II.C. Project Readiness

The Proponent Letters include letters from the LGU (Sangguniang Bayan, Sangguniang Panlungsod, Sangguniang Panlalawigan), Government Agencies (e.g., DPWH, DOT, DBM, DILG, OP), House of Representatives, and Senate. Other certifications may include minutes of consultation (Congressional District Representative, Local Government Officials, Business Groups/Tourism Private Sector, and Civil Society Organizations). The score sheet for consultations with key stakeholders is in Table 4. The Full/Pre-Feasibility Studies and Detailed/Preliminary Engineering Designs (both foreign assisted and locally funded), and Proponent Letters must be submitted by the RTWG if available. The score sheet for the submission of the technical road readiness documents is noted in Table 5.

Endorsements that are included in the Pre-Qualification criteria such as the Regional Development Council Endorsement and the Local Government Unit Endorsement require the following:

- a. Regional Development Council (RDC) Endorsement
 - i. The RTWG shall prepare the transmittal letter to submit for RDC endorsement the list of tourism roads proposed for the Program. This shall be jointly prepared by both the DOT RO and DPWH RO or solely prepared by one of the Departments.
- b. Local Government Unit (LGU) Endorsement

¹ Implementing Rules and Regulations of R. A. No. 9593 (2009), Sec. 3 (q) – "Primary Tourism Enterprises" refers to facilities and services that are directly related to tourism such as, but not limited to, travel and tour services: inbound travel agencies and tour operators, local tour operators, ecotour operators and tour guides; tourist transport services whether for land, sea and air transport exclusively or majority of its seats are for tourist use, including airport taxis and tourist drivers; accommodation establishments such as, but not limited to, hotels, resorts, apartment hotels, tourist inns, motels, pension houses, private homes used for homestay, ecolodges, condotels, serviced apartments, and bed and breakfast facilities; hotel and tourism estate management services; meetings, incentives, conventions and exhibition organizers and facilities; sports and recreational facilities such as, but not limited to, dive shops, amusement parks, adventure and ecotourism facilities; foreign exchange dealers and such enterprises as may be identified by the Secretary, after due consultation with concerned sectors.

i. The RTWG shall prepare the transmittal letter to submit for LGU endorsement the list of tourism roads proposed for the Program since it owns the local road and has to maintain it after improvement/construction. This shall be jointly prepared by both the DOT RO and DPWH RO or solely prepared by one of the Departments.

The scores for the Consultations under Table 4 and Technical Road Readiness under Table 5 will be added to the tourism importance score to obtain the overall project rating. In general, the order of priority of the projects for inclusion in the budget will be based on the relative overall project ratings.

III. DETAILED ROAD INFORMATION

III.A. Detailed Road Condition

The following details are required:

- a. whether the road covered by the project is already existing or not,
- b. type of road surface (gravel/asphalt/concrete),
- c. type of bridge material (timber/bailey/concrete/steel),
- d. general road condition (Good/Fair/Bad/No Assessment),
- e. shoulder width in meters (m), and

f. carriageway width (m).

The road condition should be rated based on the percentage of the road that falls under the following categories - Good/Fair/Bad/No Assessment - based on the DPWH Visual Road Condition Rating Standards (ROCOND) and evaluated by the designated Road and Bridge Information Application (RBIA) Coordinator.

III.B. Necessity of Road Improvement

The following details are required:

- a. With attached geotagged photos of proposed road project.
- b. To be prepared by the DPWH RO and issued as a requirement for the inclusion of the tourism road project for the Program due to the necessity of road improvement or road opening/construction.

In the case of road opening/construction, present a road network analysis (attach the Project Development Map/GIS Map) justifying the need for the new link to provide efficient access to the tourism center/area

In the case of unpaved roads, the carriageway width already includes the shoulder width.

III.C. Softscapes

Aside from the regular TRIP projects, softscape infrastructure proposals shall be included for the purpose of enhancing the experience and convenience, as well as improving the safety of the tourists, and/or to improve the management of the tourism site. Softscape infrastructure proposals shall not be funded by the DOT-DPWH Convergence Program but instead be endorsed to TIEZA.

- a. With the DPWH's support for the DOT's NTDP and TRIP, the Central Technical Working Group (CTWG) shall evaluate proposals endorsed by the Regional Offices (ROs) of the DOT and the DPWH for the following softscape projects and tourism infrastructure:
 - i. Streetlights
 - ii. Tourism Informational Signage (locations of which shall be determined by the DOT RD)
 - iii. Rest Rooms
 - iv. Visitor Information Centers
 - v. Viewdeck
- b. In submitting the softscape project proposal, the RTWGs shall follow the file name format below:

WHEREAS, the Philippine Development Plan (PDP) for 2011 to 2016 under the Aquino Administration aims to contribute to inclusive growth by accelerating the provision of safe, efficient, cost-effective, and sustainable infrastructure and promoting key industries such as manufacturing, agriculture and fisheries, and tourism;

WHEREAS, the DOT is the lead Philippine government agency responsible for encouraging, promoting, and developing tourism as a major socio-economic activity to generate foreign currency and employment and to spread the benefits of tourism to both the private and the public sectors in accordance with the National Tourism Development Plan (NTDP);

WHEREAS, the DPWH is the lead Philippine government agency responsible for the planning, design, construction and maintenance of infrastructure, especially national highways, flood control and water resources development systems, and other public works in accordance with national development objectives;

WHEREAS, the LGU, as provided under Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, assumes the primary responsibility for the delivery and

provision of basic services and facilities, including local roads, and the improvement of the quality of life of its constituents towards the achievement of the PDPgoals;

WHEREAS, Chapter 3, Article One, Section 25.b. of Local Government Code of 1991 states that "National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects;"

WHEREAS, the DOT and the DPWH are currently implementing the DOT-DPWH Convergence Program for Tourism Road Infrastructure Project Prioritization (TRIPP), also known as the Tourism Road Convergence Program – a joint undertaking of the identification, evaluation, prioritization, and provision of tourism infrastructure - which includes local road projects - in priority tourist destination areas in the Philippines in support of the goals and targets of the NTDP and the PDP; and

WHEREAS, in accordance with Section 85 of the General Appropriations Act for FY 2014 (R.A. No. 10633), if the National Government through the DPWH funds the construction of local roads and facilities already devolved to the LGUs, the DPWH shall, prior to the implementation of the project, enter into a MOA with the LGU-recipient requiring the latter to commit to shoulder the cost for the proper maintenance and repair of said local roads and devolved facilities.

NOW, THEREFORE, the Parties have reached the following understanding:

1. PURPOSE

The Parties wish to cooperate to ensure the efficient execution of local road projects within the LGU jurisdiction under the DOT-DPWH Convergence Program.

Accordingly, the Participants have concluded this Memorandum of Agreement (MOA) with respect to the proposed areas of cooperation in support of the stated purpose.

2. LOCAL ROAD PROJECTS COVERED BY THIS MOA

This MOA covers the following local road projects within the jurisdiction of the LGU and included in the DOT-DPWH Convergence Program for Fiscal Year ____:

3. AREAS OF COOPERATION

The Partiesshall cooperate with respect to the following areas in undertaking the abovementioned local road projects:

- A. Implementation of the local road projects, including pre-construction and construction/improvement works/activities.
- B. Maintenance of the completed local road projects, including repair and rehabilitation of the roads.
- C. Monitoring and evaluation (M&E) of the local load projects, covering their outputs (physical works) and outcomes (impact).

4. RESPONSIBILITIES OF THE DOT-REGIONAL OFFICE

On the Monitoring and Evaluation of the Local Road Projects

- (1) Provide technical assistance to the LGU staff to improve their capacity on techniques for M&E of project outcomes and impact, e.g., tourist arrivals, related businesses, employment and income.
- (2) Provide technical assistance to the LGU in providing baseline data for the M&E plan.
- (3) Share with the LGU the DOT monitoring reports on the project outcomes.

5. RESPONSIBILITIES OF THE DPWH-REGIONAL OFFICE

A. On the Implementation of the Local Road Projects

- (1) Through the DPWH Implementing Office (i.e., Regional Office/District Engineering Office), implement the project by contract, and instruct the Implementing Office to supervise and oversee the implementation of the project.
- (2) Provide the LGU with copies of the plans, programs of work, budgets, and contracts for the local road projects under this MOA.

- (3) Invite the LGU to serve as Observer in the Bids and Awards Committee during the procurement of the projects.
- (4) Provide technical assistance to the LGU staff to improve their capacity on techniques for the preparation of plans, programs of work, budgets, and construction contracts for local road projects outside of this MOA.

B. On the Maintenance of the Completed Local Road Projects

Provide technical assistance to the LGU Engineering Office to enhance its capacity on the use of effective standards, planning, practices, and worksupervision for the maintenance of local roads.

C. On the Monitoring and Evaluation of the Local Road Projects

- (1) Provide technical assistance to the LGU staff to improve their capacity on effective techniques for the M&E of the project outputs, e.g., physical and financial accomplishments, including the use of Geographic Information System (GIS).
- (2) Share with the LGU the DPWH monitoring reports on the project outputs.

6. RESPONSIBILITIES OF THE LGU

A. On the Implementation of the Local Road Projects

- (1) Assign a focal person from the LGU Engineering Office who will directly coordinate with the DPWH and DOT Regional Offices (ROs) for the implementation and maintenance of local tourism road projects.
- (2) Confirm the availability of the Right-of-Way (ROW), including the removal ofimprovements/structures and informal settlers therein, required for the projects under this MOA.
- (3) Facilitate the prompt issuance of business, construction, quarrying and related permits for the implementation of the projects under this MOA.
- (4) Provide or facilitate access by the project contractor/implementing office to material sources (e.g., quarrying sites) for projects under this MOA.

B. On the Maintenance of the Completed Local Road Projects

- (1) Thru a Sanggunian Resolution/Ordinance and Certificate of Availability of Funds, allocate adequate annual budgets out of its (a) local funds based on its Annual Investment Program, and (b) other funding sources (e.g., Special Local Road Support Fund under the Motor Vehicle User Charge Act), for the maintenance including repair and rehabilitation of the completed local road projects.
- (2) Undertake sustained maintenance on the completed local road projects, including routine and periodic repair and rehabilitation works, starting from the issuance of the Certificate of Acceptance and Turnover (i.e., after the one-year defects liability period). Give priority to the hiring of maintenance workers from the local community(s) which the projects will traverse.
- (3) Safeguard the travelway as well as the rest of the ROW of the completed road projects against improper uses and encroachments, e.g., vendors, informal settlers and houses. Conduct advocacy and orientation campaign on this subject with the concerned communities.

C. On the Monitoring and Evaluation of the Completed Local Road Projects

- (1) Monitor the implementation of the projects and report to the DPWH-RO any adverse observations.
- (2) Facilitate the provision to the DPWH-RO of inputs to the GIS for the monitoring of the project outputs.
- (3) Facilitate the provision (a) to the DPWH-RO of monitoring data on the progress and outputs of the project works, e.g., kilometers paved; and (b) to the DOT-RO of monitoring data on the outcomes or impact of the projects, e.g., tourist arrivals, related businesses, employment and income.
