### A RESOLUTION RECOMMENDING TO AWARD THE CONTRACT TO ARCHIPELAGO TOURISM CONSULTANCY INC.: HIRING OF A TRAINING SERVICE PROVIDER FOR COMMUNITY-BASED TOURISM KULINARYA FOR WOMEN IN GUIMBA, NUEVA ECIJA

WHEREAS, on July 7, 2021, Request for Quotation with Reference No. 7823065 was posted in the Philippine Government Electronic Procurement System (PHILGEPS) for the Hiring of a Training Service Provider for Community-Based Tourism Kulinarya for Women in Guimba, Nueva Ecija on July 21-23, 2021 with a total Approved Budget for the Contract (ABC) amounting to Four Hundred Ten Thousand Pesos (PhP 410,000.00).

WHEREAS, as of 10:00 AM of July 12, 2021, posted deadline for submission of quotation, only one supplier, **Archipelago Tourism Consultancy** has submitted their quotation and documentary requirements;

WHEREAS, on July 13, 2021 at 10:15 AM, BAC Committee Meeting was held for the opening of the quotations of the supplier;

WHEREAS, upon careful examination, validation and verification of all the Eligibility, Technical and Financial documents submitted, the sole supplier, Archipelago Tourism Consultancy was found compliant with all the documents specified with a submitted quotation price of Four Hundred Nine Thousand Pesos Only (PhP 409,000.00).
