KNOWN ALL MEN BY THESE PRESENTS:

This SERVICE CONTRACT executed by and between the DEPARTMENT OF TOURISM (DOT Regional Office 3) represented herein by its Regional Director Carolina DG. Uy hereinafter referred to as the FIRST PARTY, and ARCHIPELAGO TOURISM CONSULTANCY, represented herein by its owner, Mr. Jose Ramlo Villaluna, hereinafter referred to as the SECOND PARTY.

WITNESSETH: That

1. The FIRST PARTY shall conduct and facilitate the Community-Based Tourism Kulinarya Workshop for Women in Guimba, Nueva Ecija on July 21-23, 2021 and do hereby contract the services of the SECOND PARTY to provide Training Services (Logistical Arrangements, Professional fees of the resource speaker, Admin and Secretariat, Start-up Kits) in the amount of **FOUR HUNDRED NINE THOUSAND PESOS (Php 409,000.00)** inclusive of taxes and subject to the usual government accounting and auditing rules and regulations.
2. The SECOND PARTY agrees to provide Training Services (Logistical Arrangements, Professional fees of the resource speaker, Admin and Secretariat, Start-up Kits) for the conduct of Community-Based Tourism Kulinarya Workshop for Women in Guimba, Nueva Ecija on July 21-23, 2021 in the amount of **FOUR HUNDRED NINE THOUSAND PESOS (Php 409,000.00)** inclusive of taxes and subject to the usual government accounting and auditing rules and regulations in the amount cited; and
3. The FIRST PARTY hereby agrees to tender payment of the contract fees herein indicated within 30 days before the date of said event or upon check in.

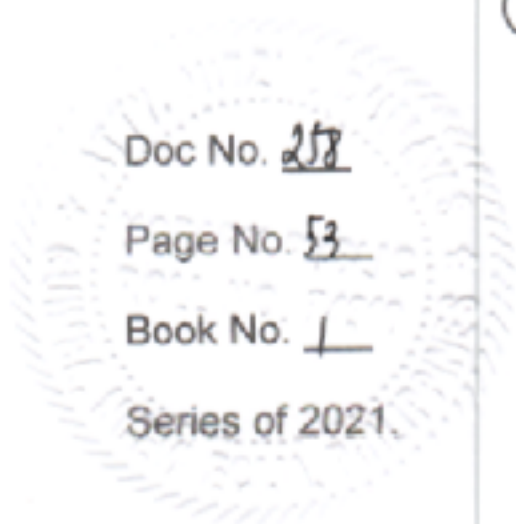
