#### **INVITATION TO BID**

The Department of Tourism – Region 3, Unit K, L, M, Former Clark Hauz Holding Corp. Along M. A. Roxas Hi-Way, Clark Freeport Zone, Philippines, through its Bid and Awards Committee (BAC), will undertake a Competitive Bidding for the *TOUR OPERATOR FOR THE TRAVEL/LOGISTIC REQUIREMENTS OF OUTBOUND TOUR* in accordance with Section 53.9 of the Revised Implementing Rules and Regulation of Republic Act No. 9184.

Location : Clark – Busuanga - Clark

**Brief Description:** 

The Department of Tourism – Region III will organize the Clark – Busuanga – Clark Travel Bubble tentatively scheduled on 4<sup>th</sup> week November 2021. This is line with the Department's strategy to reboot the tourism industry of the country through domestic tourism as well as to promote safe travel by air. The creation of travel bubbles, with tourism/familiarization exchanges between Central Luzon and other regions, will increase destination awareness, stimulate demand for travel to and from the regions concerned, and increase bookings for tourism experiences and accommodations. The regional office has previously accomplished exchanges with Cebu, Davao, Batanes, Bacolod, Tagbilaran, Iloilo, as well as the inaugural flight of Clark-Taipei, further spurring economic activity in these areas and increasing flights at Clark International Airport. However, such endeavor has been discontinued in 2020 due to the pandemic. Target participants are local tour operators, LGU officials, DOT – Region III and OPMD officers/representatives, local vloggers, other stakeholders, and business partners.

Along M. A. Roxas Hi-Way, Clark Freeport Zone upon payment of a nonrefundable fee of One Thousand Pesos (Php 1,000.00). Moreover, eligibility documents to be submitted are (i) photocopy of proponent's Department of Trade and Industry or Securities and Exchange Commission Registration Certificate, as the case maybe; (ii) Mayor's Permit; and (iii) list of previous works done and respective clients.

Online pre-bid conference is tentatively scheduled on **October 19, 2021, 2:00 pm**. Interested bidders may call the project officer for the meeting details.

Submission of eligibility and bid documents is on or **before November 2, 2021**, 12:00 pm, while opening of said documents will follow thereafter at the new DOT Region III Satellite Office, Unit K, L, M, Former Clark Hauz Holding Corp. Along M. A. Roxas Hi-Way, Clark Freeport Zone, Philippines. Late submission shall not be accepted.

The forms, which are part of the quotation documents, shall be the same forms to be submitted by the proponents for their compliance with the schedule of requirements, technical specifications, and financial proposal submission sheet. Non-compliance therewith shall be a ground for disqualification. The "No Contact Rule" shall apply. Bidders are not allowed to call or talk to any member of the BAC, TWG, or Secretariat right after the opening of the eligibility and quotation documents.

The proponent determined to have the Lowest Calculated Bid shall be required to furnish the BAC a copy of the following documents within three (3) calendar days from receipt of notice thereof:

- 1) PhilGEPS Registration;
- 2) DTI/Business Permit
- 3) Mayors Permit or its equivalent documents
- 4) DOT Accredited Establishment or applicable licenses and permits
