RESOLUTION NO. 046-2023**

A RESOLUTION RECOMMENDING TO AWARD THE CONTRACT TO SHELL PAMPANGA-CANLAS STATIONS: FUEL FOR THE SERVICE VEHICLES OF THE DEPARTMENT OF TOURISM REGION III FOR CY 2023

WHEREAS, the end-user requested for a change of mode of procurement for the Fuel for the Service Vehicles of the Department of Tourism Region III for CY 2023 from Negotiated Procurement - Sec. 53.9 Small Value Procurement (NP-SVP) to Alternative Mode of Procurement under Sec. 53.14 Direct Retail Purchase of Petroleum Fuel, Oil and Lubricant (POL) Products, Airline Tickets and Online Subscriptions with a total amount of Eight Hundred Thousand One Hundred Fifty Pesos (Php800,150.00);

WHEREAS, the end-user justified the urgency of the procurement of fuel for the service vehicles, promotes efficiency and economy, and also the utilization of funds;

WHEREAS, on June 14, 2023, the request for change of mode of procurement has been approved through BAC Resolution No. 042-2023;

WHEREAS, on June 19, 2023, the end-user conducted a comparative market study of the five (5) key players' gasoline stations nearby or strategically located near the DOT Office III to ensure that the selection of service providers must meet the requirements;

WHEREAS, on June 21, 2023, based on the comparative study, Shell Angeles owned by Shell Pampanga-Canlas Stations is the most practical and convenient. In addition, the company also met the minimum requirements prescribed by the GPPB making it a technically, legally, and financially capable company to engage with the DOT Office III and provide the needed fuel and petroleum requirements;

WHEREAS, on June 26, 2023, Shell Pampanga-Canlas Stations has submitted their quotation and documentary requirements;

WHEREAS, on June 26, 2023 at 11:18 AM, Bids and Awards Committee Meeting was held for the opening of the quotation of the supplier;

WHEREAS, upon careful examination, validation and verification of all the Eligibility, Technical and Financial documents submitted, it was found that Shell Pampanga-Canlas Stations, with a submitted quotation of Eight Hundred Thousand One Hundred Fifty Pesos (Php800,150.00), has complied and submitted all the documentary/technical requirements;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee hereby **RESOLVED** as it is **RESOLVED**:

1. To declare **SHELL PAMPANGA-CANLAS STATIONS** as the winning supplier with complete submission of all the documentary and technical requirements specified in the Request for Quotation and with the calculated quotation price of **Eight Hundred Thousand One Hundred Fifty Pesos (Php800,150.00)** for the contract Fuel for the Service Vehicles of the Department of Tourism Region III for CY 2023; and
2. To recommend to the Head of the Procuring Entity the approval for the award of the said Contract to **SHELL PAMPANGA-CANLAS STATIONS** with its Quotation of **Eight Hundred Thousand One Hundred Fifty Pesos (Php800,150.00)**.








