SERVICE CONTRACT

KNOWN ALL MEN BY THESE PRESENTS:

That this Agreement, made and entered into this 29th day of June 2023 in Clark Freeport Zone, Philippines, by and between:

The **DEPARTMENT OF TOURISM – REGION III**, a regional office of the Department of Tourism with principal office address at Clark Center, Jose Abad Santos Avenue, Berthaphil II, Clark Freeport Zone, Pampanga, represented by its Regional Director, **RICHARD G. DAENOS, PhD**, of legal age, Filipino, hereinafter referred to as the **FIRST PARTY**;

And

ANALIZA D. CANLAS PETROLEUM STATION is a private entity existing and duly registered under the laws of the Philippines, with office address at Mc Arthur Hiway, San Agustin, City of San Fernando Pampanga, represented by their owner, **ANALIZA D. CANLAS** and hereinafter referred to as the **SECOND PARTY**;

WITNESSETH: That

1. The **FIRST PARTY** shall procure Fuel for the service vehicle for office use to provide support to its operations. and do hereby contract the services of the **SECOND PARTY** to deliver the requirements indicated on the approved Request for Quotation, Terms of Reference, Schedule of Requirements, and Technical Specifications of the **FIRST PARTY** in the amount of Eight Hundred Thousand One Hundred Fifty Pesos (**Php800,150.00**);
2. The **SECOND PARTY** submitted a quotation that agrees to provide the following based on the submitted Request for Quotation (RFQ) by the **FIRST PARTY** in the amount of Eight Hundred Thousand One Hundred Fifty Pesos (**Php800,150.00**):
 - a. Fuels to be supplied must conform to the latest Philippine National Standards on Fuel, i.e., PNS/DOE QS 004:2017, with Automotive Diesel Oil (ADO).
 - b. Fuels consumed are understood to be purchased at pump prices.
 - c. Issue DOT application forms and other relevant information to be filled out and signed by the office.
 - d. Assure high-quality products and excellent services guaranteed by a Statement or Certification from the service provider that its products comply and/or conform with existing Philippine National Standards for diesel and other fuel-related products;
 - e. Provide 24/7 availability in the provision of fuel requirements by the Contractor/Supplier's fuel stations, within the duration of the Contract.
 - f. Availability and replenishment of fuel based on the hereunder estimated volume/quantity. Fuel allocation per vehicle on a month-to-month basis:


UNIT 1 - 512 liters
UNIT 2 - 512 liters
UNIT 3 - 512 liters
UNIT 4 - 513 liters

3. The **FIRST PARTY** hereby agrees to tender payment within a week after each activity in which amount depends on the number of liters ordered, inclusive of taxes and subject to the usual government accounting and auditing rules and regulations
